## Maine Coast Animal Rescue Foster Contract

As a Foster Family I/We agree to the following:

- 1. The Animal will be provided with adequate fresh food and water.
- 2. Foster Family agrees to bring the animal to veterinary appointments, including spay/neuter appointment.
- 3. Foster Family agrees to keep foster dog supervised in a secured fenced area or on a leash at all time while outside. / Or Cat indoors at all times.
- 4. Foster Family agrees to keep animal isolated in the home and quarantined from the public (ie: dog parks, stores or other public places) 5 days from transport date.
- 5. Foster Family understands that Maine Coast Animal Rescue retains legal control of the animal and is not authorized to make any legal or medical decisions on his/her behalf.
- 6. Foster Family agrees to allow potential adopters, that Maine Coast Animal Rescue has approved, to meet the foster dog/cat at the family home OR at another reasonable location.
- 7. Foster Family agrees to facilitate meetings with prospective adopters and answer questions by potential adopters.
- 8. Foster Family agrees to respond to Maine Coast Animal Rescue within twenty-four hours concerning the animal and/or Potential adopters.
- 9. Maine Coast Animal Rescue makes no guarantees regarding the dog or cat's age, breed, health or temperament. While Maine Coast Animal Rescue has made every effort to provide accurate history and assessment of the animal, Maine Coast Animal Rescue is not able to guarantee the animals age, breed, medical status, behavior or disposition. Maine Coast

Animal Rescue is available for consultation, advice and assistance pertaining to the health, training and compatibility of the animal.

- 10. All medical expenses that are approved by the Maine Coast Animal Rescue Board and treated through a Maine Coast Animal Rescues approved veterinary office will be covered by Maine Coast Animal Rescue. If you take our dog/cat to your vet it will not be covered.
- 11. Foster agrees to release Maine Coast Animal Rescue and its members or representatives of any and all possible claims arising from injury or damage caused by the animal to any person or property.
- 12. If you choose to adopt your foster animal. You will be required to fill out an adoption application. Upon receipt it will be processed to Maine Coast Animal Rescue guidelines.

  As a Foster Family, I/We release the previous owner as well as Maine Coast Animal Rescue and its Board/Representatives of any liability arising from our duties as a Foster Family, from this date forward. I/We agree to abide by the foster conditions and I/We have read and fully understand that Maine Coast Animal Rescue may repossess this animal at any time if the foster conditions are violated or the animal is mistreated. This contract applies to any fosters taken into your home from January 1,2023-December 31,2023. By signing below you are agreeing to these terms.
